## GENERAL REQUIREMENTS

- Applications must meet eligibility criteria established by state guidelines
- Maximum grant amount for any project may not exceed \$100,000
- Emissions reductions through these project must be surplus to all local, state and federal requirements
- Engine/equipment must be operational prior to acceptance in a program
- Equipment must remain operational for the entirety of the project life
- Any equipment being replaced must be destroyed, applicant must show proof of destruction

- 1. Applications are ranked by costeffectiveness (\$/ton of avoided pollutant).
- 2. Eligible projects will be chosen based on cost-effectiveness, geographic location, and previous applications received.

### **ELIGIBLE PROJECT TYPES**
