WHEREAS, said petition for the organization of the Anderson Cemetery District complies in all respects with the laws of the State of California and with the provisions of Division 8, Part 4, Chapters 1, 2, 3, and 4 of the Health and Safety Code of the State of California and with all of the provisions of Chapter 60 of the California Statutes, 1939, approved April 7, 1939, and effective except as otherwise indicated on September 19, 1939.

WHEREAS, notice of the time and place of the hearing of said petition has been published for not less than two weeks prior to the date of this hearing, to-wit, January 25, 1943, in the Anderson Valley News, a newspaper of general circulation.

WHEREAS, the Board of Supervisors did on said 25th day of January, 1943, duly pass its resolution determining and finding that said petition was genuine and sufficient and complied in all respects with the laws of the State of California and with the provisions of Division 8, Part 4, Chapters 1, 2, 3, and 4 of the Health and Safety Code of the State of California and with all of the provisions of Chapter 60 of the California Statutes, 1939, approved April 7, 1939, and effective except as otherwise indicated on September 19, 1939, and that notice of the time and place of the hearing on said petition has been published for not less than two weeks in the Anderson Valley News, a newspaper of general circulation prior to the date of said hearing, to-wit, January 25th, 1943.

WHEREAS, evidence has been introduced before said Board to establish each of the hereinabove matters and to establish each of the matters set forth and found in said resolution hereinabove mentioned.

WHEREAS, no evidence was offered in opposition to said petition.

WHEREAS, the only person residing in and or owning property within said proposed district or within an existing cemetery district or otherwise, who appeared before the Board of Supervisors at said hearing in person or by agent or attorney to oppose the creation of such a district or to request a change in the boundaries thereof was HOMER BRUCE.

WHEREAS, said Homer Bruce did not represent anyone but himself in making such protest.

WHEREAS, Homer Bruce does own less than ten per cent of the total assessed valuation of the land in the proposed district.

WHEREAS, the Board of Supervisors has determined and does hereby over-rule the protest of said Homer Bruce.

WHEREAS, the Board of Supervisors has determined not to make any changes in the boundaries of the proposed district.

WHEREAS, the Board of Supervisors has determined to create the Anderson Cemetery District and to define and establish the boundaries thereof as hereinafter set forth.

NOW, THEREFORE, IT IS HEREBY RESOLVED, FOUND AND DECLARED by the Board of Supervisors of the County of Shasta as follows, to-wit:

1. That all of the foregoing recitals are true and correct.
2. That said petition for the formation and creation of the Anderson Cemetery District as originally presented is hereby approved.
3. That there is hereby created and declared to be a duly organized and established cemetery district to be designated and known by the name of the Anderson Cemetery District and the boundaries thereof are hereby fixed and determined to be that certain property situated in the County of Shasta, State of California and more particularly described as follows, to-wit:

The exterior boundaries of the territory comprising the Anderson, Lone Tree, and Latona Elementary School Districts, which are particularly described as follows, to-wit:

Beginning at the intersection of the Westerly boundary of the P.B. Reading Grant and the center line of Clear Creek in Township 31 North, Range 5 West, MDB&M. and running thence Easterly down Clear Creek along its centerline to an intersection with the centerline of the Sacramento River; thence Southeasterly down the Sacramento River along its centerline to a point 25 feet Northerly from an intersection with the Northerly bank of Cottonwood Creek; thence Westerly parallel with and distant 25 feet Northerly from the North bank of Cottonwood Creek to an intersection with the North & South midsection line in Sec. 7, T. 29N., R. 3 W.; thence Northerly along Midsection lines to an intersection with the Easterly right of way line of the S.F.R.R. in Sec. 31, T. 30 N., R. 3 W.; thence Northwesterly along the Easterly right of way line of said R. BUCKEYE AND UNION SCHOOL DISTRICTS - BOUNDARY CHANGES

This being the time set by the Superintendent of Schools for hearing the Petitions to change the Boundaries of Buckeye and Union School Districts and proof of posting and of mailing of notice being on file and the School Superintendent having filed her written recommendation, oral protest of Fred Smith is heard. Protest is overruled and on motion of Supervisor Chatham, seconded by Supervisor Turner the following resolution is passed:

RESOLUTION AND ORDER CHANGING THE BOUNDARIES OF THE UNION AND BUCKEYE ELEMENTARY SCHOOL DISTRICTS OF THE COUNTY OF SHASTA, STATE OF CALIFORNIA.

WHEREAS, on the 5th day of January, 1943, there was filed with LUCY HUNT, as Superintendent of Schools of the County of Shasta, petitions signed by at least ten heads of families in each of the Buckeye and Union Elementary School Districts of the county of Shasta, state of California, a petition setting forth and requesting a change of boundaries of the Buckeye and Union Elementary School Districts;

WHEREAS, the signers of said petitions and each of them were heads of families and were American citizens or eligible to American citizenship and ten or more of said signers were residing in the Union Elementary School District and ten or more of said signers were residing in the Buckeye Elementary School District;

WHEREAS, said petition set forth the reasons for the desired change in boundaries and which said reasons were as follows, to-wit:

There are now, and have been for several years, about 150 pupils who reside in the present BUCKEYE ELEMENTARY SCHOOL DISTRICT who attend school in the UNION ELEMENTARY SCHOOL DISTRICT. The Union District schools are closer to the homes of these children; and it is more satisfactory from all points of view that they attend a school in the Union District. The proposed change will cause the residences of all but two or three of these pupils to be included in the enlarged Union Elementary School District.

WHEREAS, said Lucy Hunt as County Superintendent of Schools of Shasta County examined said petition and found the same sufficient and signed as required by law and thereafter set the same for hearing by the Board of Supervisors at a regular meeting thereof on the 25th day of January, 1943, at the hour of 2 o'clock p.m.

WHEREAS, evidence was introduced before said Board of Supervisors in support of said petition;

WHEREAS, no evidence was offered in opposition to said petition and only one person, to wit: Fred Smith, opposed the granting of said petition;

WHEREAS, the Board of Supervisors has determined to and does hereby over-rule the objection of said Fred Smith

WHEREAS, the Board of Supervisors has determined to grant and approve said petition and to order the change of boundaries requested in said petition;

WHEREAS, it is hereby determined by the Board of Supervisors that it is to the public interest and to the interests of said Buckeye and Union Elementary School Districts and each of them, to grant and approve said petition and to make the change in boundaries as therein requested and hereinafter set forth;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of the County of Shasta, as follows, to wit:



RESOLUTION-SUSTAINED YIELD PROGRAM IN BURNEY WORKING CIRCLE

Mr. Fred Haynes, Mr. Karl Elling and Mr. Raymond H. Berry, representing the Burney Chamber of Commerce and Burney lumbering interests, request co-operation in an effort to obtain federal legislation to provide for a sustained yield program in the Burney Working Circle of lumbering operations.

On motion of Supervisor Colby, seconded by Supervisor Chatham, the following resolution is passed:

WHEREAS, the timber and lumber industry is one of the outstanding industries of Shasta County, and vitally affects the welfare of its inhabitants, and in fact, the City Redding and the entire county would be directly affected if its sawmills were to cease operation, and,

WHEREAS, there exists in Eastern Shasta County constituting the Burney Working Circle over 150,000 acres of virgin timber supporting an over-mature stand of Sugar and Ponderosa Pine, Douglas and White Fir and Incense Cedar of over four billion board feet, 125,000 acres of which is held by private owners some of whom are threatening to log large areas by depletion cutting and take the timber thus removed to adjacent counties.

WHEREAS, the removal by depletion cutting of large quantities of timber by private

WHEREAS, further depletion cutting would prevent the establishment of a sustained yield operation in the lumber communities of Shasta County and would result in making such communities "ghost towns" after the forests had been cut off under present cutting practices, and,

WHEREAS, such further depletion cutting would also seriously decrease the taxable wealth of Shasta County and present sources of tax revenues would be lost, and

WHEREAS, such further depletion cutting of the forest in Shasta County would affect our water sheds by removing the forest cover which would result in the silting up of dams and reservoirs, all of which would affect the power plants now existing and under construction in this water shed and which would have further and far reaching adverse effects on the Shasta Dam and Central Valley Project.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED on this 7th day of June, 1943, by the Board of Supervisors of the County of Shasta:

(1) To foster and encourage the policy of obtaining Federal Legislation to provide for a Substantial Yield Program in the Burney Working Circle;

(a) To insure the continuance of an ample supply of timber so as to enable the sawmills in Shasta County to remain permanently in operation.

(b) To stabilize employment, taxable forest wealth and the economic life of Redding and Shasta County.

(c) To prevent the destruction of present timber resources in Shasta County by depletion logging.

(d) To secure the benefits of conservative forestry practices in the regulation of water supply and stream flow, the prevention of soil erosion and the preservation of wild life in Shasta County.

(2) To cooperate with the Redding Chamber of Commerce and the Burney Chamber of Commerce to achieve such Federal Legislation.
