## Instructions to Complete Statement of Withdrawal

The information on this form is a public record.

Business and Professions Code § 17930

Providing false information on this form is a misdemeanor and is punishable by a fine of up to \$1,000.00.

Business and Professions Code §17923

Any general partner withdrawing from a partnership that is doing business using a fictitious business name may file a statement of withdrawal. The withdrawal must be filed with the county clerk of the county where the fictitious business name statement was filed.

Filing a statement of withdrawal does not cause a fictitious business name statement to expire.

Please provide the following information on the front of this form:

- 1. The fictitious business name(s).
- The street address of the business.
  The mailing address of the business if different and listed on the most recent fictitious business name application.
- 3. The name(s) and business address(es) of the general partner(s) withdrawing from the business(es). Must match the most recent filing of the fictitious business name.
- 4. Check the box which best describes the partnership. Must match the most recent filing of the fictitious business name.
- 5. The file number and filing date of the most recent fictitious business name statement. This information is on the client copy of the most recent fictitious business name statement. It is also available on the Shasta County Clerk website, https://www.shastacounty.gov/county-clerk/page/fictitious-business-name, under "Search Business Name," or by contacting the Shasta County Clerk's Office. ## Instructions for Publication

Business and Professions Code § 17917, 17922

When a general partner files a Fictitious Business Name Statement of Withdrawal, it must be filed in the county where the fictitious business name statement was filed and must be published in a newspaper in that county within 45 days of filing. The statement must be published once a week for four uninterrupted weeks and proof of publication must be filed with the county clerk within 30 days after the last week.
