Items 5: Home Visiting Collaborative Update: Liz Poole present on an Implementation Grant received two years ago \$199995. Grant was extended out to Beginning Summer 2023. Grant for Home Visiting Coordination with First 5 CA. Focus to strengthen the collaboration between partners. Increasing cross-agency understanding of local population needs. Development of charter between organizations around collaboration. Building a marketing campaign around home visiting to reduce the barriers to families from receiving services. 'No wrong door policy' to be implemented. Asked for members to provide any ideas on trainings. Evaluation support and training to home visiting staff and partners. Subcontracted with SCOE since they house 'Help Me Grow'. Developed a Referral Tree in process. Embedding Implementation Team Home Visitors into Help Me Grow- Help Me Grow Collaborative. Discussed

website has button for getting referred to 'Help Me Grow' and link to 211. Liz updated from First 5 the Nurturing Father training. The link is on their web page.

<u>Items 6:</u> CalWORKs Home Visiting Program Update: Member Denise Hobbs mentioned CALWORKS home visiting program participating in evaluation of NFP, HFA, and PAT (Parents as Teachers). CALWORKS Home visiting Program approved for next year. Discussed criteria for enrollment has been changed and client can enroll before the 2nd trimester.
