Item 7: Update: COVID, Robin Schurig

Public Health Branch Director Robin Schurig gave an overview of the Public Health Branch's response to the COVID-19 pandemic. Shasta County had its first case of COVID in March 2020, and opened its Department Operations Center (DOC) in response, which was mostly operated by the Public Health Branch. Shortly thereafter, it was realized that the emergency would be ongoing, and a County-wide Emergency Operations Center (EOC) was opened. This included collaboration with other county departments, including the Sheriff's Department, and other agencies, including CalFire, who have experience in incident command structure. They then turned the response over to the HHSA, so it was again a DOC, with HHSA leadership fulfilling roles of Incident Commander, Logistics Chief, Planning Chief, etc. before the DOC demobilized in June 2021. Although the EOC has demobilized, the Public Health Branch still has over 40 extra-help employees who are doing COVID related work. New funding streams have been allocated that will help fund the COVID response and will increase public health infrastructure in the coming years to help support future emergency responses. Current priorities of the PH Branch in relation to the COVID-19 pandemic include decreasing vaccination hesitancy in the community.

Health & Human Services Agency & Public Health Branch Director's Report - Public Health Advisory Board September 8, 2021

CURRENT ISSUES:

Health & Human Services Agency (HHSA) Update

- Amber Condrey was appointed as the Deputy Branch Director for Children's Services in July 2021. Amber
 has extensive experience developing and implementing programs in Children's Services and was most
 recently an HHSA Program Manager.
- Kerri Schuette was appointed as Deputy Branch Director for the Office of the Director in July 2021. Kerri has extensive experience overseeing the Community Relations Unit and the Outcomes, Planning and Evaluation (OPE) Unit as an HHSA Program Manager. Recently, Kerri has been the Public Information Officer (PIO) for the Shasta County COVID Response.

Public Health Branch Update

- Our staff have been under a great deal of stress during the pandemic, and for some this was just the latest in a long line of disasters they've been involved in responding to (Carr Fire, "snowmageddon," measles, etc.). So, on August 24th and 25th our branch hosted a Stress Support Event for staff. The schedules included individual 20-minute therapy sessions and one-hour group sessions, as well as a group training on Preventing Burnout each day. Based on Survey Monkey feedback, this was a "Great Training!" and several people requested access to a recorded version. We sent out a link to the recorded for those who weren't available for the live sessions. This is just the beginning of things we're trying to do to support the wellbeing of our staff.
- Healthy Communities Division: Suicide Prevention program is providing Questions, Persuade, Refer (QPR) Gatekeeper trainings to community groups interested in this 1-2 hour training. There are nine trainers in Shasta County who can provide this Gatekeeper training. Our one trainer at Public Health has recently provided 4 trainings to a total of 80 community members. Additionally, we have partnered with Lotus Educational to provide more in-depth Suicide Prevention training programs: 23 local educators & school counselors received 16 hours of Applied Suicide Intervention Skills Training (ASIST) training in August. Two 4-hour safeTALK trainings were held on August 16th. Suicide Prevention Week is September 5th through 11th.

Healthy Shasta is promoting Cycle September with a focus on engaging high school and college students to increase biking for transportation. The month-long challenge kicked off September 1st. Healthy Shasta staff visited lunch breaks at 5 high schools to increase interest in this challenge. Anyone can join the challenge. Visit healthyshasta.org for more information.

Healthy Brain Initiative, focusing on increased awareness of Alzheimer's and dementia, coordinated a training to local first responders on signs to look for and ways to approach individuals with dementia during a crisis or emergency.

• Specialty Health Services Division: The Local Oral Health Program (LOHP) is currently working on a School-Based Oral Health program to reduce the barriers to access and improve Oral Health in Shasta County. The goal is for every single Kindergartener to receive a Kindergarten Oral Health Assessment in the short term, with a long-term goal that all students are receiving screening and fluoride varnish and sealant applications. Recent screenings were conducted at Excel

Academy. Hill Country Community Clinic also conducted Oral health screenings in the previous school year. In coordination with the LOHP Advisory Committee, LOHP will work with the Shasta County Office of Education to coordinate additional school-based oral health program services.

• Healthy & Safe Families Division- Shasta County will be receiving additional allocations from the Substance Abuse Prevention and Treatment Block Grant (SABG) thanks to the Coronavirus Response and Relief Supplemental Appropriations Act and the American Rescue Plan Act. This includes \$150,000 for Friday Night Live (which will be passed along to Chemical People) and \$552,022 for Primary Prevention (Public Health programming), with various timelines through June 2025.

An RFP is now open for local non-profit organizations, schools, or cities to receive up to \$115,000 to implement youth alcohol and other drug prevention strategies during calendar year 2022. RFP deadline is September 24, 2021. Received permission to alternatively fill the Maternal, Child and Adolescent Health Coordinator position with a Supervising Public Health Nurse. The funder highly prefers a nurse fill this position, and this will allow us to offer the higher Supervising PHN pay if a qualified nurse is identified. Recruitment will be released soon.

• Community Engagement and Quality Improvement Division- The MAPP Steering Committee met for the first time since January 2020. Each member will look at the priority areas, objectives, and key actions within their organization's sphere of influence and bring back their thoughts and ideas on how to update the Community Health Improvement Plan.

Staff continue to support the COVID response by helping the county's healthcare system navigate the current surge, through supporting administration of local case investigation, bringing vaccines to community members, and providing technical assistance to community-based organizations who are implementing COVID vaccine and COVID safety outreach and incentives.

Emergency Preparedness Staff and the Director of Nursing continue to respond to the increased number of fires surrounding Shasta County. This includes coordinating nursing, shelter staff, resources, and communications at the shelters for evacuees.

• Community Health Protection Division- The Community Health Protection (CHP) division has been preparing for the launch of a mobile STD clinic, which we expect to begin providing STD testing services to underserved populations in the fall.

Additionally, the CHP division continues to respond to COVID, by supporting case investigation, contact tracing, testing, and vaccination efforts. During the current surge due to the Delta variant, the teams have prioritized investigating cases in vulnerable settings and providing support to local employers and schools in mitigating outbreaks.
