# DHCS Promulgation of Regulations for STRTPs







### **Promulgation of Regulations**

DHCS in consultation with CDSS, shall promulgate regulations regarding STRTPs:

- > Program standards and oversight, enforcement
- > Issuance of mental health program approvals
- Includes provisional approvals effective for less than one year
- Due Process protections related to the Mental Health Program Approval process







### **Promulgation of Regulations**

DHCS will be implementing and administering these processes through:

➤ Information Notices or similar written instructions until regulations are adopted.





### Transition from RCL 13/14 Certs to STRTP Mental Health Program Approval

#### RCL 13/14 Certifications

DHCS remains the oversight agency for the group home RCL 13/14 Certifications

- ➤ Currently *delegated* to the MHPs
- Renewal by MHP through transition to STRTP or termination







#### **AB 1997 & STRTPs**

#### **Bottom Line**

- ➤ STRTPs will maintain the level of care and services necessary to meet the needs of the children and youth in their care
- STRTPs will maintain and have in good standing the mental health program approval and Medi-Cal certification for Medi-Cal specialty mental health services (SMHS)





#### **AB 1997 & STRTPs**

- > STRTPs cannot directly provide SMHS without a current Mental Health Program Approval.
- ➤ Mental Health Program approval is a condition for receiving an Aid to Families with Dependent Children-Foster Care rate pursuant to Section 11462.01.
- STRTPs that have not yet completed the program approval process must still provide access to appropriate mental health services until their program approval is completed.





### STRTP Medi-Cal Certification to Provide Mental Health Services

#### At a minimum, STRTPs must:

- Be Medi-Cal Certified to provide the following SMHS as medically necessary
  - a. Mental Health Services
  - b. Crisis Intervention
  - c. Medication Support
  - d. Targeted Case Management
- 2. Provide access to other mental health services based on individual need







#### **Placement Criteria**

The child has been assessed, pursuant to WIC Section 4096, <u>AND</u> meets one of the following:

- 1. Meets the medical necessity criteria for Medi-Cal SMHS per Title 9, CCR, Section 1830.205 or 1830.210; and/or
- 2. Is seriously emotionally disturbed, as defined in WIC Section 5600.3(a); and/or
- 3. This level of service is necessary to meet the behavioral or therapeutic needs.







#### **Additional Placement Criteria**

Additionally, STRTPs may have a specialized program to serve the following:

- (A) A commercially sexually exploited child.
- (B) A private voluntary placement, if the youth exhibits status offender behavior, the parents or other relatives feel they cannot control the child's behavior, and short-term intervention is needed to transition the child back into the home.







#### **Additional Placement Criteria**

(C) A juvenile sex offender.

(D) A child who is affiliated with, or impacted by, a gang.

(WIC Section 11462.01(b)(4))

# Components of STRTP 1.11

- Delegation of Program Approval/Certification process
- Application for Mental Health Program Review
- Application for Mental Health Program Renewal Approval
- Medi-Cal Certification







### Mental Health Approval and Medi-Cal Certification Process

The STRTP Protocol for the Mental Health Program Approval & Medi-Cal certification are combined:

- Decreases duplication
- ➤ Streamlines the process from two (2) reviews into one (1) simultaneous site visit
- ➤ The Mental Health Program Approval will be done annually.
- The Medi-Cal certification will be done tri-annually.







# Components of STRTP Mental Health Program Approval

- ➤ Complaints
- ➤ Notice of Non-Compliance
- > Imposition of Sanctions
- Notice and Review Procedures (Due Process)







# Components of STRTP Mental Health Program Approval

### The major elements added to the STRTP regulations include, but are not limited to:

- 1. Application content, process, and timelines
- 2. Requires a written program plan including contents of the plan
- 3. Requires notification to the department, e.g., when there is a change to the mental health program plan
- 4. Record Retention





# Components of STRTP Mental Health Program Approval

#### The major elements continued...:

- 5. Documentation requirements includes timelines
- 6. Psychotropic medication control, e.g., monitoring, documentation, timelines
- 7. Clinical Review and Continued Stay Determinations
- 8. In-service education requirements for staff
- 9. Staff characteristics, qualifications and duties





#### **Due Process Protections**

DHCS/MHPs may enforce the mental health program approval standards by taking any of the following actions against a non-compliant STRTP:

- A. Suspend or revoke a mental health program approval.
- B. Impose monetary penalties.
- C. Place a mental health program on probation.
- D. Require a mental health program to prepare and comply with a corrective action plan.







#### **Due Process Protections**

- ➤ DHCS/MHPs shall provide STRTPs with due process protections when taking any of the actions described above in previous slide.
- DHCS/MHP shall notify CDSS immediately upon the termination of any mental health program approval.







# Provisional Mental Health Program Approval for STRTPs







### Provisional Mental Health Program Approval for STRTPs

- ➤ DHCS/MHP will review Mental Health Program Approval requests.
- STRTPs have12 months from date of licensure to obtain a mental health program approval that includes a Medi-Cal mental health certification (Sections 4096.5 and 11462.01 of WIC).





### Provisional Mental Health Program Approval for STRTPs

- ➤ May be necessary if DHCS or a MHP receives a high volume of applications in early 2017
- > Allows staggered onsite reviews
- Will create staggered subsequent onsite reviews







# Provisional Mental Health Program Approval for STRTPs

- ➤ Review of submitted documents (e.g., Application, Program Statement)
- ➤ Issued for less than one year
- ➤ Within that one year period of time (in most cases within 3 months of Provisional approval) the full onsite review will be conducted





### Two Types of Provisional Mental Health Program Approval

#### 1) EXISTING RCL TRANSITIONING TO STRTP

- ➤ A desk review (off site) for provisional approval of the STRTP's application and program description may be scheduled.
- Upon provisional status, the facility would be scheduled for an onsite review
- The full site review and approval date will set the annual rotation date.





### Two Types of Provisional Mental Health Program Approval

#### **B) BRAND NEW STRTPS**

- 1. DHCS/MHP completes "initial" site review
  - a. Checks that basic requirements are met
  - b. Determines implementation readiness
  - c. Provides TA for full site review
- 2. If the above are met: Approves Provisionally
  - a. Allows the STRTP to begin operations







### Two Types of Provisional Mental Health Program Approval

#### **B) BRAND NEW STRTPS**

- 3. DHCS/MHP will complete the full review within approximately 3 months from first admit.
- 4. Annual reviews thereafter







### Medi-Cal Certification for Specialty Mental Health Services







#### **Medi-Cal Certification for SMHS**

#### Medi-Cal certification:

- Beneficiary Informing Materials
- > Facility Inspection
- Policies and Procedures
- HIPAA/Confidentiality/Security of Protected Health Information







#### **Medi-Cal Certification for SMHS**

DHCS/MHP will accept evidence obtained from the Licensure process that is already covered as part of the licensing requirements to satisfy applicable Medi-Cal Certification requirements, **for example:** 

- ➤ A copy of the Licensing Packet may be provided with tabs and labels identifying applicable evidence for for Medi-Cal Cert requirements.
- MOUs, Letters, Copies of Licenses/Contracts







# Specialty Mental Health Services (SMHS)







### What are Specialty Mental Health Services (SMHS)

CA Code of Regs, title 9, section 1810.247 (a), Specialty Mental Health Services means: Rehabilitative Mental Health Services include:

- 1. Mental Health
  Services which
  includes but is not
  limited to Assessment,
  plan development,
  therapy, rehabilitation,
  and collateral
- 2. Medication Support Services
- 3. Day Treatment Intensive
- 4. Day Rehabilitation
- 5. Crisis Intervention
- 6. Crisis Stabilization







### What are Specialty Mental Health Services (SMHS)

- 7. Crisis Residential Treatment Services
- 8. Psychiatric Health Facility (PHF) Services
- 9. Psychiatric Inpatient Hospital Services
- 10. Targeted CaseManagement

- 11. Psychiatrist Services
- 12. Psychologist Services
- 13. EPSDT Supplemental SMHS Services TBS\*, ICC\*, IHBS\*
- 14. Psychiatric Nursing Facility Services

See Definitions of Terms in CCR, title 9, sections 810.200 – 1810.254

<sup>\*</sup>Therapeutic Behavioral Services (TBS); \*Intensive Care Coordination (ICC);

- ➤ Medi-Cal Certification
  - ➤ Original Medi-Cal Certification

- > Program Approval—Approval Agency must
  - ➤ Track Approvals
  - ➤ Monitor for Compliance—Set and collect Fines
  - Address Complaints as per Medi-Cal Complaint Protocol
    - **≻**Time Lines
    - ➤Tracking
    - ➤ Resolution

- > STRTP provides all services
- > MHP and STRTP share service delivery, eg:
  - ➤ Individual Therapy—MHP County
  - ➤ Group Therapy—STRTP
  - ➤ Med Support/as needed and 24/7—STRTP
  - ➤ Med Support/Psychiatrist—MHP County
  - ➤ Case Management—STRTP & MHP County
