# A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA APPROVING SUBCONTRACTING THE COMMUNITY SERVICES BLOCK GRANT (CSBG) FOR DISASTER RELIEF SUPPLEMENTAL FUNDING (DRSF) AND CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY (CARES) ACT FUNDING

WHEREAS, on June 30, 2020, the Board of Supervisors determined that there is a need for a disaster relief program and approved the execution of the CSBG for DRSF agreement by adopted Resolution No. 2020-058.

**WHEREAS**, on July 21, 2020, the Board of Supervisors determined that there is a need for CARES Act funding and approved the execution of the CSBG CARES agreement by adopting Resolution No. 2020-067.

WHEREAS, the CSBG DRSF Agreement Number 20F-3503 and CSBG CARES Agreement Number 20F-3683 were executed with the State of California Department of Community Services and Development ("CSD"); and

WHEREAS, at the request of CSD, agencies that receive and administer CSBG funds are encouraged to partner with other agencies to deliver services to eligible program participants in the community.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Shasta hereby authorize the Shasta County Housing and Community Action Agency Programs to subcontract the CSBG DRSF and CSBG CARES.
