Dear Agency Director:

On Tuesday, March 1, 2022, the Department of Community Services and Development (CSD) received an inquiry from the Office of Community Services (OCS) requesting a response from CSD regarding California's low CARES expenditures. The inquiry emphasized that OCS wants to ensure that the CARES funding is reaching the populations most in need prior to the expiration date.

As communicated at the quarterly CSBG Service Provider meetings and coordination calls, CSD continues to stress the critical importance of ensuring timely expenditure of CARES emergency grant funds to ensure CARES benefits are provided to California's low-income communities impacted by the pandemic. CSBG's Field Operations staff performs monthly reviews of CARES expenditures for each agency and will continue to provide support to the network through various activities to ensure CARES funds are utilized to prevent, prepare for and respond to COVID-19. Given the ongoing need that continues to exist in the state, returning funds would not be viewed favorably – at the federal, state, and local levels. To achieve our goal to fully expend CARES funding, CSD is offering the following approach:

- 1. CSD requests agencies submit CARES expenditures monthly, and no later than the 25<sup>th</sup> of the following month as per CPN-C-22-01. This is a critical step in communication with CSD on agencies' progress.
- 2. Agencies who require and request additional time to expend their allocation will be granted a term extension to August 31, 2022. CSD is requiring any agency being granted an extension to provide a clear plan for how they intend to expend the remaining dollars in the additional time allotted. If you believe such an extension is necessary for your agency to fully expend your allocation, please contact your CSBG Field Representative as soon as possible. The deadline to submit your request for a contract amendment (CSD 425b) is no later than Wednesday, March 16, 2022.
- 3. A contract amendment (for those who request it) will be distributed via DocuSign and must be executed <u>on or before May 31, 2022, to prevent any delays in execution.</u>

CSD is committed to the success of the network in providing crucial services to low-income Californians. CSBG Field Operations staff is readily available to discuss challenges and help revise

program and/or spending plans. The following are key deadlines to help inform your planning process:

- Agencies must submit a request for Contract Amendment (CSD 425b) no later than Wednesday, March 16, 2022.
- 2020 CSBG CARES Contract Amendments via DocuSign will be issued for signature on or before March 31, 2022.
- CSD must receive your executed DocuSign on or before May 31, 2022.
- The extension will run through August 31, 2022.
- CSD 715 Closeout forms and Discretionary Grant Work Plan/Final Report (CSD Form 926) will be due to CSD no later than September 30, 2022.

Thank you for your partnership and commitment to serving low-income Californians. It is important to ensure that all funds allocated to your service territory, for all contracts, are fully expended in a timely manner.
