NOTICE IS HEREBY GIVEN that the Shasta County Housing Authority, which serves Shasta, Trinity, Siskiyou, and Modoc Counties, will conduct a public hearing to discuss and invite public comment on the Housing Authority's proposed Public Housing Authority's Annual Plan (PHA Annual Plan) for Fiscal Year 2024/2025, will consider adopting the PHA's Annual Plan, and will consider finding that adoption of the Plan is not subject to the California Environmental Quality Act (CEQA) (the Plan is not a project as defined by State CEQA Guidelines section 15378 and is not subject to CEQA pursuant to State CEQA Guidelines section 15060(c)(3)), or the National Environmental Protection Act, Title 24 CFR § 58.34(a)(1) and (a)(3) (administrative and planning or strategy activity).

NOTICE IS FURTHER GIVEN that the hearing will be held in the Board of Supervisors Chambers at the Shasta County Administration Center, Room 263, 1450 Court Street, Redding, California, on May 21, 2024, at 9:00 a.m., or as soon thereafter as may be heard, at which time and place all interested persons may appear and be heard thereon. Purpose. Definitions.

- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

A Housing Assistance Payments Contract (HAP) was executed in January 2024 for Burney Common (29 PBV) in Burney, CA and we are in the process of leasing units with the property management. Agreement to Enter into a PBV HAP Contract's (AHAP) have been executed for Cascade Village, formerly Shasta Lake Project (48 PBV) and Shasta Lake Veteran's Village (27 VASH, 3 HCV PBV) both located in Shasta Lake City, CA. Sunrise Cottages (44 PBV), a development project dedicated to senior citizen's in Anderson, CA has been conditionally awarded. They are currently competing for Tax Credits to then be able to submit a SLR package.</p>
