### **Discussion Items**

a. Subcommittee members will review and discuss the Judicial Council memorandum dated May 24,
 2021, on the Division of Juvenile Justice Realignment.

Tracie Neal mentioned the date of the Judicial Council memorandum of June 30, 2021 in the agenda was an error, the correct date is May 24, 2021 and is included in the handouts. She pointed out a few of the important items in the memorandum. She said the county realignment plan is due on January 1, 2022, and the firm closure date for DJJ is June 30, 2023.

b. Subcommittee Members will discuss the Secure Track Treatment Program (STTP) implementation.

Tracie Neal reported a letter of intent was submitted to BSCC to run a Secure Youth Treatment Facility and the JRF has been certified to run a secure youth treatment facility and has received a facility number. She said the JRF has been rated at a 2-bed capacity for the STTP. Tracie stated a new state agency, the Office of Youth and Community Restoration, which will be established within the Health and Human Services Agency and will have oversite of the realignment plans. She said currently there are no youth who have been ordered to the JRF STTP.

c. Subcommittee Members will receive an update on Shasta County's Youth Program Facilities Grant Program (SB823) Application.

Tracie Neal reported Shasta County is a small county and applied for \$47,802.00 in grant funding to replace and upgrade the security system. Very few counties applied for the grant so there was extra funding available, and Shasta County received \$167,549.00. Tracie went over the projects and how the extra funding would be used.

Subcommittee members will review, discuss, and consider approving updates to the Shasta County Probation Department Secure Track Treatment Program (STTP) Division of Juvenile Justice (DJJ) Realignment Plan or provide further direction to staff.

Tracie Neal reviewed the changes to the DJJ Realignment Plan. They included some typo's, changed some language on page 5, added the facility number on page 13, and on page 24 added data that pertain to race, gender, and ethnicity.

Laura Stapp moved to approve the changes; Cindy Vogt seconded; Motion passed; 7 ayes, 0 noes.
