## **Probation Reports**

### **Juvenile Probation Division**

Carla Stevens shared she is the Juvenile Division Director now. Carla said Stacie Bouyear will be leading a CSEC group at Juvenile.

### **Juvenile Rehabilitation Facility (JRF)/River's Edge Academy (REA)/Secure Track Treatment Program (STTP)**

Jeremy Kenyon said all youth who came back from DJJ have been released. Tracie Neal said Parent Project has just started. Chelsey Chappelle shared Probation was successful in getting a grant to help with CalAIM.

Jeremy Kenyon and Carla Stevens shared a little bit about Rising Scholars. All youth in the JRF will be dual enrolled in college courses. They are working on getting a culinary arts program and other vocational programs in the JRF. Chesley Chappelle shared the Rising Scholars Grant allows for a teacher from Shasta College to be on the JRF campus providing curriculum. Eric Jones added both Rising Scholars and the California Youth Partnership started yesterday.

Eric Jones shared the JRF population is currently at 36 youth. Eric shared the population breakdown in the JRF. Eric shared there was a shift change within the JRF this week. Eric also shared two of the REA youth will be speaking at a student voice panel with SCOE this afternoon on the topic of substance abuse.

Tracie Neal shared the JRF is getting ready to celebrate their 10<sup>th</sup> anniversary next week, January 24, 2024, and there will be a lobby open house. There are several events planned for staff. Tracie highlighted some accomplishments and facts about the JRF over the last 10 years.

Jennifer Coulter asked about the demolition of the old juvenile hall. Tracie shared information about the demolition and the bidders conference.

### **Discussion Items**

- a. **Interview of Juvenile Justice Commission Member** – Betty Cunningham introduced Carrie Graves. Carrie shared some information about herself, her work in the community with justice involved youth and foster youth, and why she would like to be a member of the JJC. Jackie Durant asked about AB702 and the removal of funds for juvenile justice.

Betty asked about putting the JRF inspection on the next agenda.

Kaitlyn Wendland asked some questions regarding some of the topics that were mentioned in the meeting.
