Fee Schedule for Residential and Commercial Collections

July 1, 2023

Effective July 1, 2023 Contractor shall be permitted to collect no more than the following monthly fees for base residential collection services:

96 gallon service	\$33.32/Month
64 gallon service	\$28.80/Month
64 gallon senior citizen service (65 or older)	\$11.34/Month

Existing users of the Senior Citizen Tag program may purchase waste collection tags at a cost of \$5.17 per tag. The tags are to be attached to waste containers when they are set out for collection and such wastes will be collected without a monthly charge. Alternatively, tagged wastes may be deposited for free at any transfer station operated by Contractor.

Residential Recycling Contamination Charge = \$33.71 per container, per occurrence after initial warning
Charge for 15% or more garbage in recycling container, as determined by visual assessment conducted by collection vehicle driver during collection operations.

Commercial Recycling Contamination Charge = \$84.27 per container, per occurrence after initial warning.

Charge for 15% or more garbage in recycling container, as determined by visual assessment conducted by collection vehicle driver during collection operations
